2. Teacher input report – Xaviera and James

Xaviera reported from a survey sent to teachers that (in order) teachers' would like to request the following for School Land Trust funds: (1) class size reduction with either an additional teacher or paraprofessionals (interventionists); (2) continue with playground program "Playworks"; (3) any technology needs in the school

3. Technology update – Rene

Rene reported that, according to our technology report, other than miscellaneous desktops that are being reclaimed there are no large purchases scheduled for this year. The next large computer lab purchase is scheduled for 2021. Small purchases can be made from local school budgets. One teacher requested a chromebook cart which can be purchased this year with a Confucius Grant.

4. Discussion around next year's budget and school funding – Paul

We are currently looking at using \$7,000 toward the "Playworks" Program for next year, and possibly using the remainder of the budget for class size reduction – either a teacher, if needed, and determined after meeting with the district on FTEs allotted for next year – or used for paying for paraprofessionals (interventionists). We will vote on this next month (March).

It was discussed that we may not need to meet for an April meeting.

The Council would like to know how they can help with the proposed bond. Could Rene ask a District or School Board member to address this in our next meeting.

We need to see who is going off the Council next month to get ready for SCC elections in April/May.
