School Update: Principal's Message: Chris Fuhriman

There are 3 cases in school, and we have been doing a lot of contact tracing. An entire 6th grade class was quarantined. Teachers are doing better but still under stress. The amount of students in home study is down to 30 from 90. Teachers are doing lots of prep to arrange for in-class and home learning. The teachers are overachievers. Parents want to know how they can help from home. It's a difficult time since no parent volunteers are allowed in the building, but parents are encouraged to continue extending support and tell teachers of their appreciation.

Budget Review: Income and Expenses: Cheryl Bikman, Treasurer
 In the past month, PAWS received \$88 of t-shirt income, \$838 in donations for
 Mrs. Pratt's gift, and incurred \$10 of expense to renew our 501c3 certificate from the state.

2. Proposed Amended Changes to By-Laws: Emily Craig The following are proposed changes to the by-laws:

Article III: Policies

F. Subject to the exceptions enumerated in this paragraph, P.A.W.S. funds shall not be used to purchase gifts and no part of the net earnings of this Organization shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons. except this Organization shall be authorized and empowered to pay The following are exceptions for which P.A.W.S. funds may be used: reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set for in Article III hereof. The funds of P.A.W.S. shall not be used to purchase gifts outside of funds used for teacher expense accounts, and gifts to School, de minimis back-to-school gifts for staff/administration, and de minimus end-of-year thank you gifts to Organization's Board.

Article VIII: Duties of Officers

- E. The treasurer shall:
- 6. Co-sign all checks; Facilitate online access to bank accounts and accounting software for President, Co-President and Treasurer-Elect to allow for oversight;
- 11. Maintain record of volunteer hours for seven (7) years and submit such record to appointed tax accountant(s) as needed for filing with reports to governmental agencies;
 - G. Follow the expenditures policy as stated herein:
- 1. Pay out funds for expenditures for amounts less than \$100.00 only upon authorization of the president of president-elect. Changes to the approved budget are to be voted on by the Board of Directors.
- 2. Pay out funds for expenditures for amounts greater than \$100.00 only when authorized by the Board of Directors.

Article IX: Commissions, Board of Directors and Special Committees

C. The Executive Committee and the commissioners comprise the Board of Directors of this Organization. Regular meetings of the Board of Directors shall be held during the year, the time to be fixed by the Board of Directors at its first meeting of the

year. Members of P.A.W.S. may attend, without the right of voice or vote, all meetings of the Board of Directors but may be granted permission to speak at these meetings provided they have contacted the presiding officer of the meeting and requested to be placed on the agenda. A majority of the Board of Directors shall constitute a quorum. Special meetings of the Board of Directors may be called by the president or by a majority of the members of the Board, all members of the Board having been notified.

3. Commissioner Chair Focus:

a. STEM Fair: School Support: Pam Smalley, Marec Cavendar We have been in contact with Mrs. Isom. She has created a google application for parents to fill out when volunteering to judge the STEM fair. A link was circulated out to the PAWS board. To enter the STEM fair, students will upload a zoom video. Top 5th and 6th grade entries will then go on to the district fair.
